

Consolidated Rail Infrastructure and Safety Improvements (CRISI)

Summary: CRISI funds projects to improve railroad safety, efficiency, and reliability; mitigate congestion at intercity passenger and freight rail chokepoints to support more efficient travel and good movement; enhance multi-modal connections; and lead to new or substantially improved Intercity Passenger Rail Transportation corridors. Eligible Projects include:

- Deployment of railroad safety technology including positive train control & rail integrity inspection systems
- Capital projects necessary to address congestion or safety challenges affecting rail service
- Highway-rail grade crossing improvement projects
- Rail line relocation or improvement project
- Capital projects to improve short-line or regional rail infrastructure
- Preparation of a regional rail & corridor service development plan & corresponding environmental analyses
- Projects necessary to enhance multimodal connections or facilitate service integration between rail service & other modes, including intercity rail passenger & intercity bus service or commercial air service
- Development & implementation of safety programs or to institute design to improve rail safety
- Development & implementation of measures to prevent trespassing & reduce injuries/fatalities.
- Research to advance any aspect of rail-related capital, operations, or safety improvements
- Workforce development & training activities coordinated with Transportation, Labor or Education
- Research, development & testing to advance & facilitate innovative rail projects, including
 projects using electromagnetic guideways in an enclosure in a very low-pressure environment
- Preparation of emergency plans for communities through which hazardous materials are transported by rail
- Rehabilitation, remanufacturing, procuring, or overhauling locomotives, provided these activities result in a significant reduction of emissions
- Deployment of Magnetic Levitation Transportation Projects

Eligible Applicants: States, groups of states, Interstate compacts, public agencies or publicly chartered authorities established by a State, political subdivision of states, Amtrak or other rail carrier, Class II or Class III railroads, Tribes, Transportation Research Boards/Universities, or non-profit labor organization.

Maximum Grant Awards & Match: There are no minimum/maximum award amounts, but several set-asides. There is a total \$2.478 billion available (combines FY23 and FY24). There is a 25 percent set-aside for Rural projects. Required match is 20 percent.
